
This is how it works:



Order a company online at www.standardbolag.se

We always have shelf companies ready for delivery. The simplest way to order is via our online form at www.standardbolag.se. Call one of our offices if you need assistance, telephone numbers can be found at the bottom.

Owner of the company



After we have received all necessary details, we send a bank authorisation for deposit of share capital, purchase contract and registration documents (posted or mailed depending on which method of delivery you prefer).

You become owner of the company on the date the purchase contract is signed.

Return signed document



Contact bank of your choice in order to open an account and deposit the company's share capital. Sign the documents and return them to us, including a bank certificate that the share capital has been deposited. After we have received the signed documents, we send a general power of attorney for the company's new representatives.

Registering the case



The case is now sent to the Swedish Companies Registration Office for registration. We are involved throughout the process and provide assistance if problems should arise with, for example, name chosen for the company. When the case has been registered and is completed, you receive the company's certificate of registration.

Company folder



Within a few weeks, we send a company folder containing share certificate, share register, articles of association and other documents pertaining to your limited company. You can supplement the folder with other important documents which concern the company so that everything is in one place.
